

## TRANSFER OF LICENSE FORM

**Transfer of License is subject to approval by Autodesk.** The undersigned parties submit the following information in support of a request to transfer Autodesk software licenses ("Product(s)") as a result of the following transaction:

### TRANSFER METHOD A: Transferring License to another company (check only one box below):

- Company sale:** Where all assets including software licenses are sold to another company.
- Company merger:** Where companies merge resulting in the formation of a new company and the newly formed company takes ownership of all assets of the merged companies.
- Company acquisition:** Where a company is acquired by another company and becomes its subsidiary, all of the software licenses registered in the name of the subsidiary may be transferred to the Parent company.
- Company divestiture:** Where a company sells a subsidiary, division, business unit, or facility, to a third party, or when a division, business unit or facility is separated from the parent company and begins operation as an independent company.
- Dissolution of a partnership:** Where the licenses are split between the partners of the partnership only.
- Privatization of license owner:** Where the license owner was a government-owned or controlled company that has become privatized.
- Donations to Non-Profit:** Where the transfer is a donation to a non-profit organization. License(s) intended only for use by the non-profit organization, not for resale or further donation by the Non-Profit organization.

### TRANSFER METHOD B: Transferring License from one country to another (check only one box below):

- Same company:** Transferring from one country to another.
- Different companies:** Transferring from one country to another (also check one box from Transfer Method A).

**The following requirements MUST be met:**

- License(s) must be on the latest release of the product and on Subscription.
- Transferor and the Transferee must sign this form.
- Current license is registered in the name of Transferor.
- After Transferor receives an email of TOL approval, Transferors must uninstall the approved Autodesk product(s) from their computer immediately.
- All transfers may be subject to a license transfer fee, per seat or per transaction, as indicated by Autodesk.
- Product must be available for sale on the price list published in the Transferee country and purchase order must be processed in the Transferee country. (Applicable for "Transfer Method B" only)
- License(s) must have been used in the country of purchase for at least a year from the registration date. (Applicable for "Transfer Method B" only)
- Transferee and Transferor are solely responsible for; i) complying with United States, and other applicable, export controls laws; and ii) obtaining and paying any costs associated with customs, export or other documentation required by any jurisdiction in transferring the license(s) from one country to another.

## TRANSFER OF LICENSE FORM

**CERTIFICATION FOR ALL TRANSFERS: SIGNATORIES BELOW CERTIFY AS FOLLOWS:**

The parties acknowledge that use of the transferred Products is subject to compliance with the Software License Agreement that originally accompanied the Product, or the Software License Agreement that accompanied any Upgrade to the Product. Additionally, should Autodesk approve the requested transfer, Product licenses would remain non-transferable as to the Acquiring Party, absent Autodesk further written consent. By signing below, the Transferring Party (Transferor) agrees to relinquish its interest in, and license to use, the above-referenced licenses, and has destroyed or transferred all other copies of the transferred Product licenses in its possession to the Transferee, if any. The Acquiring Party agrees to assume all terms and obligations under the relevant Software License Agreement(s).
